

How Santa Clarita Cut the Length of Permit Counter Visits by 70%

The City of Santa Clarita is the third largest city in Los Angeles County and the 24th largest in the state of California. In 2018, the city's Building and Safety Division issued 5,364 permits and performed 29,288 building inspections - equating to around \$300 million of new construction for the city.





Past Problems

The City of Santa Clarita grappled with a high volume of visitors and applications at their Permit Center. Visitors often waited in line only to learn that their project didn't need a permit. Permit Center staff used paper handouts and a website to help educate residents about the permit process. But, the resources didn't help customers self-serve, leading to more calls and meetings.
